

# Community Activity Center Usage Fees As Approved by Town Council

*Usage fees* means those fees that are charged to persons desiring to use the Flower Mound Community Activity Center. Such usage fees shall be established for daily use admission, membership fees, and facility rentals.

*Nonresident* means a person who lives outside the territorial jurisdiction of the town.

*Resident* means a person who lives in the territorial jurisdiction of the town.

*Family* means persons who live in the same household and who are related by either blood or marriage such that they may be claimed as a spouse or dependent based upon applicable IRS regulations.

*Youth* means a person who is equal to or between the ages of three and 17 years old.

*Adult* means a person who is equal to or between the ages of 18 and 59 years old.

*Senior* means a person who is 60 years of age or older.

*Daily pass* is valid only on the date of purchase.

*Monthly Pass* is paid monthly by an EFT draft or month-to-month at the Center. Monthly passes will not be sold after the 15<sup>th</sup> of each month for the remainder of the current month unless the next full calendar month is also purchased.

*Annual Pass* is valid for 365 days from the date of purchase.

(1) Fees and Refunds

(a) *Fees*

- i. Usage Fees for the Flower Mound Community Activity Center are hereby established. Such Usage Fees are set forth in Appendix A of this Code.
- ii. All other charges or fees, including but not limited to classes and programs held at the Flower Mound Community Activity Center will be determined by Town policy as approved by the Park Board.

(b) *Refunds*

Annual Pass

- i. *Non-refundable.* For those individuals choosing to purchase an annual membership by paying for one year in full, an Annual Pass is non-refundable after a 30-day Opt Out Period.
- ii. *30-day Opt Out Period.* All Annual Pass membership holders have 30 days from the date of purchase of the Annual Pass membership to request a refund. An amount equal to one month's membership, at the current monthly membership rate, will be deducted from the annual pass refund amount at time of refund.

Monthly pass

- i. *Non-refundable.* For those individuals choosing to purchase a monthly pass, a monthly pass is non-refundable after the date of purchase.
- iii. *Electronic Transfer.* For those individuals choosing to pay membership fees via Electronic Funds Transfer, a 30-day written notice is required to discontinue membership.

(c) *Deposits*

- i. A deposit for the rental of all or a portion of the Flower Mound Community Activity Center is required. Applicable deposits are set forth in Appendix A of this Code.
- ii. *Refundable deposit* is required on facility rentals, and on an entire facility rental, along with the completion of a facility reservation agreement and full payment. The deposit will be refunded if the area used has been left in good order and all conditions of the contract have been met. Refundable deposits may be reduced by any and all damage caused by user or user's guests or invitees.

(d) *Reservations*

- i. Reservations will be accepted on a first come, first serve basis based on availability and must be made a minimum of 3 days in advance. Flower Mound residents may book a reservation up to 12 months in advance. Non-residents are allowed to book reservation up to 6 months in advance.
- ii. All current members of the Community Activity Center will be given a 10% discount off of the current resident rate for facility rentals. To receive the discount, the membership holder must have a current membership at the time of reservation and their membership must be current on the actual date of the facility rental.
- iii. In order to receive a full refund for a facility rental, notice must be given no less than 14 days prior to the date of the rental. If notice is not given 14 days prior to the rental date the full amount of the rental will be retained; however, the deposit will be refunded in full.
